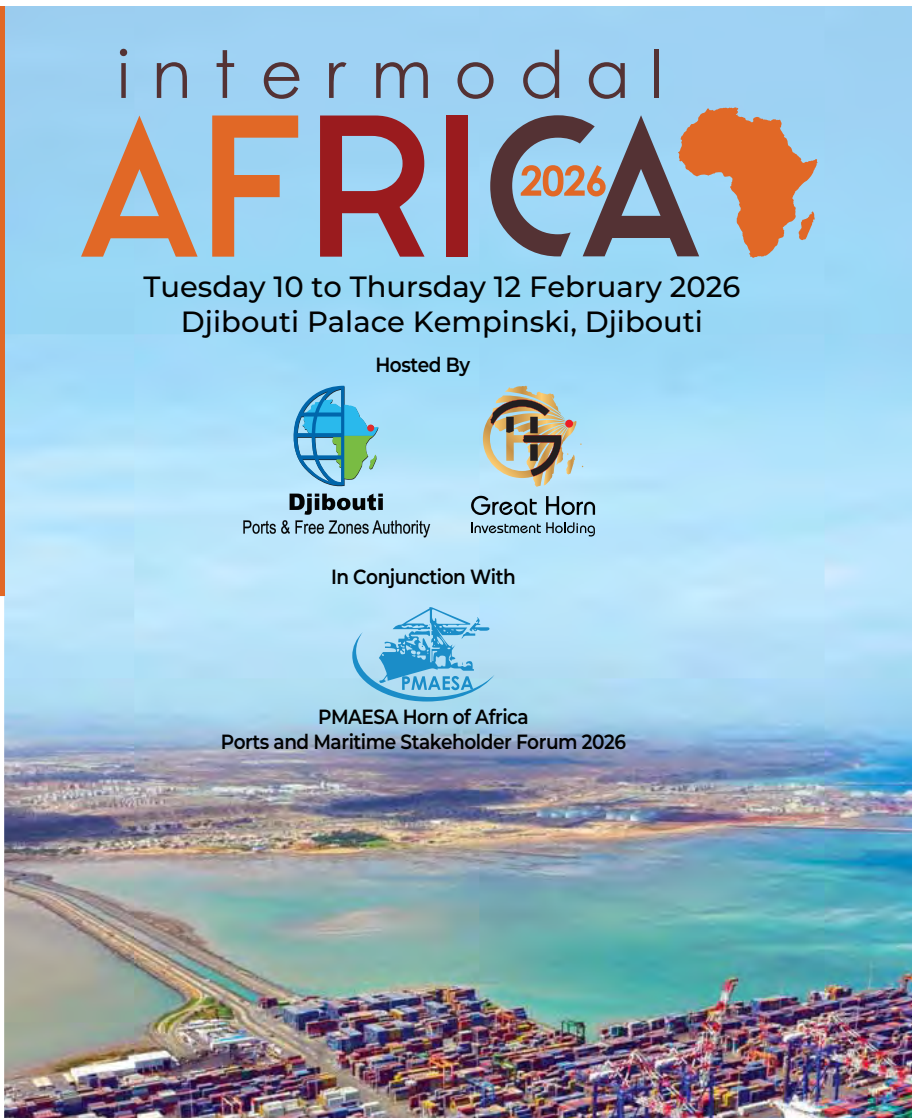

### **The Port of Mombasa records a traffic milestone of 45.45 million tonnes in 2025**

Cargo volumes through the Port of Mombasa have hit a record 45.45 million metric tons for the period January to December 2025.

This is a 10.0 percent increase or 4.46 million metric tons in comparison to 2024 when the port handled 40.99 million metric tons.

Similarly, significant growth was attained in container traffic reaching a total of 2.11 million TEUs, against 2.00 million TEUs in 2024, representing a growth rate of 109,797 TEUs, or 5.5 percent.

In a media briefing to release the Kenya Ports Authority performance outlook for 2025, Managing Director Capt. William Ruto also announced that, transit cargo followed a similar trajectory after posting 15.88 million tons from 13.29 million tons in 2024, which translates to 2.59 million metric tons or 19.5 percent.

The MD also noted that every port facility registered growth with the Port of Lamu recording the highest improvement... [Click here to read more](#)

## GMA & Danaos Shipping Strengthen Ties to Boost Global Placement of Ghanaian Seafarers

The Ghana Maritime Authority (GMA) has reinforced its strategic partnership with global shipping giant Danaos Shipping and its local representative, Safety Marine, in a major drive to increase the placement of Ghanaian seafarers on international vessels.

According to the Director General of the GMA, Dr Kamal-Deen Ali, the Authority is streamlining certification processes and working to resolve long-standing visa challenges as part of an ambitious roadmap to expand seafarer promotion and recruitment in Ghana.

“The GMA is committed to walking the

road with its partners to ensure that Ghana remains a premier hub for maritime labor in West Africa,” Dr Ali said.

### Recruitment Drive

Dr. Ali made these remarks during a courtesy call by representatives from the Greece-based Danaos Shipping Company and Safety Marine.

### **Visit of the EUNAVFOR Atalanta mission by Heads of Mission of EU Member States accredited to Kenya**

Chargé d'affaires a.i. of the Republic of Poland, Mr Marcin Kubiak, participated in the extraordinary meeting in Mombasa of Heads of Missions of the EU Member States accredited to Kenya.

The purpose of the visit was to meet with the Governor of Mombasa County, Abdullswamad Sheriff Nasser, and to visit the Spanish frigate "Victoria", which is performing combat tasks as part of the European Union's EUNAVFOR ATALANTA

Operation. During a briefing organised by the commander of the 51st rotation of the EU Naval Force in Operation Atalanta, Commodore João Silva, and the ship's commander, Commander Jorge Fernández de Navarrete, the history, scope of the mandate and current activities of ATALANTA were presented. ## SONA 2026: President Boakai Backs NPA Reforms to Break Port Monopoly

In a defining moment for Liberia's maritime and trade sector, President Joseph Nyuma Boakai, delivering his third State of the Nation Address (SONA) 2026, again strongly reaffirmed the centrality of the National Port Authority (NPA) to national economic recovery, trade facilitation, and structural transformation of Liberia. The President's remarks stand as a powerful national endorsement of the reform agenda being executed by the NPA Management Team under the leadership of Managing Director Sekou A. M. Dukuly, and the Board of Directors.

President Boakai recounted a landmark

development emerging from his official engagement in Morocco about two months ago. This engagement according to President Boakai with the leading Moroccan port development entity (Tanger Med) has resulted in a commitment to invest in strategic port equipment, logistics systems, and terminal infrastructure at the Freeport of Monrovia. The President noted that this investment is crucial toward expanding the Freeport and constructing modern bulk cargo terminals at the LMC Pier, thereby decompressing port congestion, diversifying terminal operations, and structurally lowering the cost of doing business at the Port of Monrovia....
